



# Charitable Gift Annuity Rates

## Effective Rates for 2019

### What is a Charitable Gift Annuity?

In short, it is an agreement in which a donor makes a gift to their parish, school, diocese or other Catholic entity under the Diocese of Sioux City.

In turn, the donor receives **guaranteed annual income payments** for the life of one or two persons.



#### A Single Life Gift Annuity

Is based on the life of one person.



#### A Two-Life or Joint Gift Annuity

Is based on the lives of two persons. The gift is provided by both parties. Payments are made to both persons for life, then to the survivor. The rate is based on their ages and is determined by a two-life rate table.

### How often are these rates changed?

The American Council on Gift Annuities Board of Directors reviews the rates on a regular basis.

On April 24, 2018 the board re-examined the assumptions inherent in the gift annuity rate schedules and approved an increase in the suggested maximum rates currency in effect. This change was in effect as of July 1, 2018.
